CAREER OPPORTUNITY ADVOCACY CASE MANAGER

POSITION OVERVIEW

Working with and reporting to the Supervisor of the Advocacy Program, this position is accountable for providing individual advocacy services to victims/survivors of domestic abuse. This role will require direct client care with victims/survivors of domestic abuse of diverse cultural backgrounds, specifically within Black, Indigenous, and communities of color. This position includes, but is not limited to, services that are client-centered, trauma-informed, culturally specific, systemic, and have a holistic approach. The Advocate provides follow-up on police reports, attends criminal and civil proceedings in Hennepin County, provides victim/survivors with support and information about the criminal justice system process, conducts safety planning and crisis support, assists in writing Orders of Protections, and provides resources and referrals to community agencies as necessary.

In addition, the advocate will also be doing some case management with participant served. This will primarily be with victim survivors of domestic abuse and their families. Which could also include participants from internal team programs. In this role, advocates will be responsible for providing coordinated entry screenings for victims that are homeless, or at risk of homelessness due to fleeing abuse. Advocates will provide resource connection, community collaboration and agency/program collaboration; and create case plans with participants served.

Lastly, this position requires insight, modeling of reflection and learnings, as well as incorporating discussions about power and privilege, power and control, witnessing and experiencing domestic violence and sexual assault, toxic masculinity, historical and intergenerational trauma, parallel process of DV dynamics and secondary trauma into team meetings and supervision with the understanding that this is integral to effective service delivery and team management. The Advocate will be expected to participate in program development, case consultations, weekly meetings, and trainings, as well as community outreach.

This position requires advocates to be in-person on site with the option of offering telehealth and virtual services according to the needs of program participants.

DESIRED QUALIFICATIONS

- minimum 1+ years of advocacy experience and passion for ending violence against victims is preferred
- Strong communication and interpersonal skills including oral and written communication, team building, working with and engaging clients and colleagues
- Computer skills: Microsoft office, email, data entry
- A general interest in social justice, women's issues, domestic abuse, human rights, and advocacy
- Ability to work with people from diverse racial, cultural and social-economic backgrounds
- Bachelor's Degree in Social Sciences, Liberal Arts or related, is required.
- Bilingual applicants, LGBTQIA+, Black, Indigenous, Latinx, Asian and people of color encouraged to apply.
